

**SCHEDULE OF
CONSERVATION MEASURES
IN FORCE
2003/04 SEASON**

(As amended by the Commission at the Twenty-second Meeting,
27 October to 7 November 2003)

This schedule lists conservation measures adopted by the Commission in accordance with Article IX of the Convention on the Conservation of Antarctic Marine Living Resources.

At CCAMLR-XXI, the Commission introduced a new numbering system for conservation measures in force. Under the new system, each measure is identified by an Arabic number consisting of a leading 2-digit code designating the category to which the measure belongs, and a trailing 2-digit code uniquely identifying the measure within that category; the year in which the latest version of the measure was adopted or revised follows in brackets. The numbering system for resolutions remains unchanged.

All cross references to conservation measures in this publication refer to measures in force unless clearly specified otherwise.

The map depicts the CCAMLR Convention Area and its statistical areas, subareas and divisions.

The texts of the CCAMLR System of Inspection and the CCAMLR Scheme of International Scientific Observation are appended.


